His courses, offered in Brussels and Paris, were quite expensive, the monthly fee being the amount of the monthly wage for a worker. In 1860 his Paris gym was expropriated without compensation in connection of the development of the Champs-Elysées. The government never sympathised with his ambitions, although gymnasia were multiplying in Paris, and he died in extreme poverty in 1881. Triat's work has never been given its true value. He tried endlessly to persuade the Belgian and French governments to introduce proper training for gymnastics teachers. Triat's gymnastics were athletic, unlike the more military type taught elsewhere. His ideas were utopian - in 1855 he suggested a meeting similar to the Olympic games, long before the work of Baron Coubertin. He introduced gymnastics for women, in Liège in 1839. An unusual but interesting piece.



The prompters were the brothers of Louis XVI - Louis Stanislas Xavier, then the royalists' regent of France, and Charles Philippe, the comte d'Artois. These two eventually both became King of France, as Louis XVIII (1814-1824) and Charles X (1824-1836).
